### **United Service Company**

NAMI's Individual Placement and Support (IPS) program has been able to assist local businesses with their hiring needs. IPS is



unique in that it facilitates the connection between quality, pre-screened candidates and local employers.

Creating partnerships with local businesses is, ideally, a mutually beneficial endeavor. Considering United Service Companies is in a market that often is left without recruiting assistance, collaborations with organizations like NAMI help contribute to the diversity of the applicant pool and responsiveness with the overall recruitment process. Our partnering hiring manager had this to say about our IPS clients:

"We don't consider them [IPS applicants] any differently. They are held to the same standards as all other candidates."

Comments, like the one above, illustrate how well prepared our clients are when applying for positions. With the guidance of our employment specialist, our clients find their way to the top of the hiring pile, without any special considerations due to their mental illness diagnosis.

Occasionally, accommodations are requested by employees. An IPS client that requested an accommodation be made, was recently hired by United Service Companies. The hiring manager had this to say about the situation,

"He [IPS client] stated that he had an obligation on Sundays and that he was looking for a small number of hours initially, as he was re-entering the workforce after some time. The business model of United Service Companies allowed for these accommodations. Considering there are a number of part-time positions available, it was relatively easy to work with these requests."

Understanding and accommodating businesses, like United Service Companies, greatly aid NAMI's IPS efforts in placing individuals in competitive employment positions. Not all clients request accommodations, but when they do, it becomes a rewarding experience to both satisfy an employer through aiding their hiring needs and help an individual living with a mental health condition gain access to a job.

United Service Companies is constantly looking for trustworthy, hardworking, and determined applicants to fill a number of positions. The United Service Companies' connection to NAMI's IPS program has expanded the pool of qualified and competitive applicants that are now applying for open positions within their organization. an incredibly rewarding experience,

"Things have been much better. Working for United Service Companies has taken me, financially, from red to black. Having good, flexible hours has made a difference in my recovery."

Seeking competitive employment opportunities is a difficult process. However, with the assistance of IPS services and utilizing the connections our Employment Specialist possesses, the process of getting back into the job market is slightly eased.

"It was hard getting back into the job market. I sent a number of resumes to multiple businesses without much response. Once I began working with LaDora, she had the connections to employers that I was missing out on. LaDora was able to provide reassurance that there are possibilities out there; you just have to be patient."

One of the greatest challenges of joining the job market while living with mental illness is that working on recovery is also a full-time job. Therefore, occasional accommodations need to be made in order to keep an individual on their path toward full recovery. Larry was able to to work directly with his hiring manager to devise a schedule that was going to be conducive to both parties. Luckily, United Service Companies had a number of opportunities that would be able to work with Larry's requests.

Recovery is certainly not a linear path and sometimes clients working on maintaining good mental health can experience bad days that make them question their dedication to recovery. Larry has been able to identify motivational factors such as his daughter, family members and occasionally has to tell himself to, "Get the lead out and move!".

Experiences like Larry's are the reason why IPS is so successful. Individuals with a lived experience become empowered through employment opportunities that not only better their financial state, but also provide them with the motivation necessary to continue working towards full recovery!
